## **Section 3. Summary of Impact**

A hardworking family of five will soon move into a new safe, efficient, and affordable home in Moncks Corner, SC, with the support of Berkeley Habitat and The Joanna Foundation!

Mom and dad work alternating shifts, so one of them can always be home with their three young sons. They are currently in over-crowded, temporary housing, while they work with other Habitat volunteers on site to help finish their own new home. They so look forward to "a place that is ours and (where) our boys can be in a safe environment". Mom is recovering from recent open-heart surgery, and they know a new home will give her a place of comfort, as she gets well.

Their home, to be completed in the next two months, will be the second house on Hutchinson Lane, the new affordable neighborhood Habitat is building with community support, like that offered by The Joanna Foundation. It is being constructed using a sustainable, non-combustible concrete (rather than wood framing) building system. This method lowers upfront construction costs and will reduce homeowner utility and insurance costs in the long term, due to system durability and energy performance. In addition to their home, concrete framing is underway on the next house and the concrete pad has been poured for the fourth Habitat home on the lane. Volunteers for this Foundation supported project have included the family, other past and future Habitat homeowners, community members, business and industry groups, and college students from around the country, spending their Spring school breaks, in service to others. Students volunteers on this home came from OH, MA, MD, and PA. The 2024 Habitat "Women's Build" event will also work on The Joanna Foundation house.

The home is nearing exterior completion, with additional inside work scheduled for the weeks ahead.
